#### **AMENDED**

#### ARTICLES OF INCORPORATION

OF

PagASA ng Pinoy Mutual Benefit Association, Inc.

#### KNOW ALL MEN BY THESE PRESENTS:

We, all of legal age, and majority of whom are Filipino citizens, on this date have voluntarily associated ourselves together for the purpose of being the incorporators to form a non-stock, non-profit Mutual Benefit Association (MBA) under the laws of the Republic of the Philippines. (as amended by the members and the Board of Trustees on December 18, 2014)

#### THAT WE HEREBY CERTIFY:

FIRST: The name of the said association shall be:

PagASA ng Pinoy Mutual Benefit Association, Inc.

SECOND: That the purpose for which such association is formed are:

- a.) To extend financial assistance to its members, spouse children and parents in the form of death benefits, total and permanent disability (TPD), sickness benefits, retirement savings and loan redemption assistance (credit life);
- b.) To ensure continued access to benefits/resources by actively involving the members in the management of the association that will include implementation of policies and procedures geared towards sustainability and improved services; and
- c.) To ensure compliance with administrative and regulatory issuances, rulings and directives by professionalizing the association, management, research and development, and technical services operations.

THIRD: That the place where the principal office of the association is to be established or located is at:

EIGHT: That no part of the income which the association may obtain as an incident to its operation shall be distributed as dividends to its members, trustees or officers subject to the provisions of the Corporation Code on dissolution. Any profit obtained by the association as a result of its operation, whenever necessary or proper shall be used for the furtherance of the purposes enumerated in Article II, subject to the provisions of Title XI of the Corporation Code of the Philippines.

NINTH: That MR. GENARO L. KONG has been elected by the members as Treasurer of the association to act as such until his successor is duly elected and qualified in accordance with the by-laws, and that as such Treasurer he has been authorized to receive for and in the name and for the benefit of the association all contributions or donations paid or given by the members.

TENTH: That the association manifests its willingness to change its corporate name in the event another person, firm or entity has acquired a prior right to use the said firm name or one deceptively or confusingly similar to it.

ELEVENTH: That the association shall comply with the requirements for non-stock corporations in the course of its operation.

#### By-Laws

ARTICLE V – TRUSTEES, Sec. 2. Composition

To change the composition of the Board of Trustees by increasing the number of its members to **fifteen (15)** and to delete references to the specific names of the members comprising the Board of Trustees.

- (ii) Removal of all references to "Pagasa ng Masang Pinoy Foundation, Inc." and/or "PMPFI" and replacement with "Pagasa ng Masang Pinoy Microfinance, Inc." and/or "PMPMI" in the following:
  - a.) Article III Secs. 1(b) & 7
  - b.) Article V Secs. 2, 3, 4, & 5

"PMPFI" refers to "Pagasa ng Masang Pinoy Foundation, Inc.", now known as "Pagasa ng Masang Pinoy Microfinance, Inc." or "PMPMI". The change of corporate name took effect on February 26, 2018 upon approval by the Securities and Exchange Commission.

#### ARTICLE V

#### TRUSTEES

Section 2. Composition. – The Board of Trustees of Pagasa ng Pinoy Mutual Benefit Association, Inc. shall consist of thirteen (13) members, seven (7) of whom shall be employees of the head office of Pagasa Philippines Lending Company, Inc. ("PPLCI" or Pagasa ng Masang Pinoy Foundation, Inc. ("PMPMI"); one (1) from North Luzon Division; one (1) from National Capital Region/Central Luzon Division; one (1) from South Luzon Division; one (1) from North Mindanao Division; and one (1) from South Mindanao Division; and two (2) independent trustees, all of whom, shall be elected by the active members with existing loans funded by the PPLCI and PMPMI or staff, employees or otherwise personnel of PPLCI and PMPMI. (As amended by the members and the Board of Trustees on 29 October 2018)
